

**CT BARBER EXPO 11—2022 VENDOR NON--REFUNDABLE AGREEMENT**

This Agreement is made by and between **Major Entertainment Group, LLC (“Host”)** and \_\_\_\_\_ (**“Vendor”**).

The **Host** shall organize the **CT BARBER EXPO 11 (“Event”)** at the **Mohegan Sun Casino located at 1 Mohegan Sun Blvd, Uncasville CT (“Venue”)** on **May 14-16, 2021**.

The **Vendor** has agreed to compensate **Host \$ \_\_\_\_\_** to secure space at Event. The **Vendor** and **Host** agree to the following terms and conditions:

**Vendor** will access the Venue and the assigned space as follows:

- Large Vendor Booth (10x20 and larger) & Sponsors -- **Saturday May 14, 2021 between the hours of 2:00pm to 7:00pm**
- All other Vendors-- **Saturday May 14, 2021 from 2:00pm – 7:00pm & Sunday May 15, 2021 between the hours of 8am to 12pm**
- Any **Vendor** arriving after 12 pm on Sunday May 15, 2021 shall forfeit the assigned space and all deposits/payments shall NOT BE REFUNDED \_\_\_\_\_ (**Vendor to Initial here**)
- Vans ok to load on rear loading dock-- box trucks larger than 14 Feet must pay union fees.

**Shipping to Venue:** Shipping and storage charges are the sole responsibility of the vendor. Please refer to Exhibitor Kit for information.

**Vendor** shall not share space with other brands **WITHOUT** prior written consent from the Host.

**Vendor** spaces shall be clean and orderly; and shall follow all applicable laws and regulations of Uncasville and State of Connecticut. Sales and Use Tax compliance can be found by visiting [WWW.CT.GOV](http://WWW.CT.GOV)

**Vendor** may exhibit goods for sale only while Vendor/Staff is within the area of the assigned space.

**Vendor** is not permitted to set up and use sound amplification devices without prior approval.

**Vendor** shall have 1 (ONE) Hour following the conclusion of Event (aprox. 7:30 PM) to dismantle and remove all items from the Venue. **Vendor** shall leave the assigned space free from trash/debris and in the exact condition prior to setup.

**Vendor** agrees to Hold Harmless the Host from any and all damages/claims in connection to the Vendor and its Staff’s participation in Event.

**Vendor** WILL BE ISSUED **3 VENDOR PASSES** per 10x10 space. Additional vender passes are available per request at General Admission cost.

Force Majeure: In the case of failure or delay in the performance of this contract arising out of or caused by, forces beyond it’s control including, without limitations, work stoppages, natural catastrophes or Acts of God such as but not limited to violent storm, plague, epidemic, pandemic, outbreaks of infectious disease or any other health crisis, including quarantine or other employee restrictions. Due to the effects of any such failure or delay, the Host will put the vendor’s nonrefundable booth fee towards the rescheduled or future event in good faith.

**Vendor** acknowledges that this is a NON-REFUNDABLE AGREEMENT and no deposits/payments shall be reimbursed for any reason of cancellation by **Vendor**,

except if the Event is cancelled by Host at which time you will be notified by the Host and/or Staff.

**Applicable Law**

This contract shall be governed by the laws of the State of CT, Uncasville CT and any applicable Federal Law.
